**ORDER**

In the Government Order read as 3<sup>rd</sup> above, Government have ordered among other things that tender excess upto 10% over revised SoR will be approved by the Administrative Department with the approval of Government Tender Committee for works having technical sanction upto Rs.750 Lakh. It was also ordered that vide reference G.O. cited 4<sup>th</sup> above, the minutes of the Government Tender Committee should be got approved by Minister (Finance) and Ministers concerned.

2) Government have now reviewed the above position and have decided to modify the powers of Government Tender Committee as follows:

- i) Hereafter Government Tender Committee will have the power to sanction tender excess upto 15% over the latest SoR.
- ii) All proposals involving tender excess exceeding 15%, of latest SoR, will be scrutinized by a Committee of Secretaries with Chief Secretary as Chairman, Principal Secretary (Works), Principal Secretary (WRD), Principal Secretary (Finance) and the Secretaries of the department

concerned as members. The recommendation of the Committee shall be placed before the Council of Ministers for final approval.

The Government Orders referred to above stands modified to this extent.
